# Livingston High School Hall of Fame

## 2015 Nomination Process and Criteria

The Livingston High School Hall of Fame was established in 1992 to honor outstanding alumni who have contributed substantially to their profession or in service to the community at large.

Nominations for recognition may be made by individuals or groups. The nominee must be able to attend *Homecoming Weekend* events and not have been previously inducted in the Livingston Hall of Fame. (*Past inductees listed on page two.*) Nominations do not guarantee selection. Nominees not selected for this year will be kept for future consideration.

### **Honoree Participation**

Hall of Fame honorees will participate in activities as part of the *Annual Livingston Homecoming Weekend – 2015* that will include

- Friday Morning and Luncheon
  - Celebration at Livingston High School
    - Visit with LHS students for
      - A welcoming reception;
      - To speak in
        - o several selected classrooms, and
        - one large group setting;
      - Lunch
- Friday or Saturday Evening
  - Attend and accept award at the semi-formal Hall of Fame Reception. Honorees will be asked to provide a list of guests to be invited on their behalf by the LEF to:
    - attend the dinner, and/or
    - honor the inductee in the Hall of Fame Roll of Honor.

The weekend will be coordinated with the LHS high school football schedule.

Selection will take into account the nominee's willingness to participate in this process with the understanding that the weekend will take place in October of 2015 and is part of a fund-raising effort to support the educational initiatives of the Livingston Public Schools.

#### **Nomination Categories**

#### One person shall be selected from each of four (4) categories:

#### 1. Science and Math

- a. **Health Professions –** Involvement in health occupations or health related issues.
- b. **Science –** Architects, engineers, environmentalists, researchers.
- c. **Innovation in Science or Math** Envisioned, developed and implemented a new idea with potential for benefiting the community and society in general.

#### 2. Social Sciences

- a. **Civic Leadership –** Service on the local, state or federal level that has advanced the quality of life for the residents of Livingston.
- b. Communications Involvement in public relations, media, marketing, advertising or related fields.
- c. **Education –** Involvement, service, advocacy, or policy making in education at the early childhood through grade 12 level.
  - i. Can be combined with any other category otherwise specifically to Social Sciences.
- d. **Education (Higher Education) –** Involvement, service, advocacy, or policy making at the college/university level.
  - i. Can be combined with any other category otherwise specifically to Social Sciences.
- e. **Innovation General -** Envisioned, developed and implemented a new idea with potential for benefiting the community and society in general.
- f. **Law -** Involvement in the legal field.
- g. **Public Service -** An official who has served or is serving by election, appointment or employment in a governmental position.
- h. **Volunteerism -** Involvement, in an **unpaid** capacity, in a notable effort that has had a major impact on the community.
- 3. Creative Arts Involvement in visual, performing, media, or literary arts.

#### 4. Business and Technology including:

- a. Business & Finance Involvement in banking, business ownership, investments, or finance.
- b. **Technology –** Database, Information Management, Internet, Hardware/Software development, Systems Analysts
