1.Main Argument: The cameras will help observe the public, and see all the events that would happen while the camera is rolling.

Evidence: Barbara O'Connor the director of Security at Uconn has ordered in for 7 officers to wear body cameras around campus. She say "believes the **body cameras** will provide an extra level of transparency". And these cameras will be monitoring students all day.

2. Main Argument: Video recorded by body cams protect any false accusations, misconduct, or abuse against officers. These cameras will help police officers from being unrightfully blamed for actions they did not do.

Evidence: With our bill the cameras will be on all time when they leave their station, if it is not on they will face a fee. This way it will be easier to figure out when a cop arrests someone without saying the Miranda Rights.

3.Main Argument: The use of cameras would lower the number of criminal police brutality deaths and injuries. Also the video evidence of the camera would help in court prove the officer was guilty.

Evidence: In August of 2015, 776 people were killed by Police and 161 whom were unarmed. By November of 2015 the deaths surpassed 1000 people. This data was found by a project called "The Counted" a continuously updated, interactive database of police killings in the United States. This database is the most accurate database in the United States, the government has a similar database. Police kill an average of 3 people a day.

Part VIII: Government Spending

Contributing to the funding will be mandatory. In the first year each state has to raise \$2,189,010 to pay for the cameras. And since about 318,857,056 people lived in the U.S. during 2014 they should pay about \$0.34 for the cameras and \$1.14 in fees so a family should pay about \$1.48 per person in the first year but \$1.14 for the following years that we will use them.
