# 1. Maintaining Health and Safety

### A. Universal and correct wearing of masks:

The Livingston Public Schools (LPS) will comply with NJDOH Guidelines and make adjustments to plans on an ongoing basis. As long as mask wearing mandates remain in place from the New Jersey Department of Health, all students and staff will be required to wear masks as per the guidelines. It is expected that parents will provide masks for their children. If a child arrives at school and does not have a mask, the school will provide a mask for the child to wear throughout the day. Students will be instructed in the proper way to wear a mask, and will be periodically reminded about mask wearing procedures.

## B. Physical distancing (e.g., including use of cohorts/podding):

The Livingston Public Schools will comply with NJDOH Guidelines and make adjustments to plans on an ongoing basis. Students will be distanced in classrooms and on school grounds in accordance with the recommendations from the NJ Department of Health and the Centers for Disease Control as guidance is communicated to schools. Based on current policy, schools in the district will create an environment for social distancing within the classroom to the maximum extent practicable. Use of shared objects will be limited or supplies will be cleaned between uses.

#### C. Handwashing and respiratory etiquette:

LPS will comply with NJDOH Guidelines and make adjustments to plans accordingly. As we have done during this school year, LPS will continue to ensure that there are multiple hand washing and hand sanitizing stations throughout the schools. Particular focus will be on the entrances and exits, in classrooms and near lunchrooms and toilets. Students will continue to be reminded to wash their hands throughout the school day, particularly before and after eating. Students will be organized and taken to wash their hands during designated times. Schools will continue to monitor students who may be symptomatic for COVID-19 and will immediately separate any student who is exhibiting symptoms. Schools will encourage students to cover their mouth and nose when they need to cough or sneeze. Due to increased droplet spread in certain classes, spacing for students in classes such as PE and music will be optimized and add'l precautions to adhere to respiratory etiquette will be taken.

#### D. Cleaning and maintaining healthy facilities, including improving ventilation:

All spaces will be cleaned daily following a 3-step process: 1.Clean dirt from all surfaces with attention to high touch areas like desktops, doorknobs, and chairs. 2.Thoroughly disinfect spaces using our hospital-grade disinfectant, recommended by the CDC to kill viruses. 3. Custodians will complete cleaning checklists for each classroom and restroom, which will be posted in the corresponding spaces. While school is in session, custodians will carry a spray bottle of hospital grade disinfectant and a clean dry cloth. We will continue working with our certified HVAC specialists to assess air filtration and circulation. We have already purchased and installed enhanced filters in our ventilation systems adhering to guidelines. HVAC systems are cleaned regularly, and filters will be changed in line with the experts' recommendations. Windows are opened whenever possible to increase ventilation.

- **E. Contact tracing in combination with isolation and quarantine, in collaboration with the State, local, territorial, or Tribal health departments:** Contact tracing is the process used to identify those who come into contact with people who have tested positive for many contagious diseases including COVID-19. Upon notification that a resident, student, or staff member has tested positive for COVID-19, the local health dept will call to determine close contacts to whom they may have spread the virus; close contact is defined as being within six feet for a period of at least 10 mins. Trained professionals then get in touch with those close contacts to recommend next steps, such as self-quarantining, and to provide critical education and support in risk mitigation strategies. Increasing the number and capacity of contact tracers has been a top priority of the Governor as these practices can help slow the spread of COVID-19. LPS will continue to work closely with the Livingston DOH to help keep the community safe as it pertains to contact tracing. LPS will follow guidelines of the NJDOH and update practices as those guidelines evolve.
- **F. Diagnostic and screening testing:** The Livingston Public Schools will comply with NJDOH Guidelines and make adjustments to plans on an ongoing basis. Protocols will be in place for daily health screenings of students, teachers, administrators, and staff. This will be done through an Electronic Symptom Checking Survey this initial screening will be used to complete the necessary questions as per the NJ Department of Education (NJDOE) and the Centers for Disease Control and Prevention (CDC) protocols for live school. This check-in system must be completed by parents for each student prior to departing for live school. Detailed information regarding this electronic symptom check survey and its use will be provided prior to the opening of school. This screening process will continue as long as it is recommended by the New Jersey Department of Health (NJDOH). The procedures surrounding the screening will be modified based on advice from the NJDOH and the local department of health.

# G. Efforts to provide vaccinations to educators, other staff, and students, if eligible:

The Livingston Public Schools will comply with NJDOH Guidelines and make adjustments to plans on an ongoing basis. The district will continue work proactively with the local department of health, county officials, and our district physician to encourage eligible members of our staff to be vaccinated, and will assist staff members in accessing vaccine sites and appointments. The district will also continue to provide the necessary opportunities during the school day, if needed, for our staff to take the time to leave work in order to be vaccinated.

## H. Appropriate accommodations for children with disabilities with respect to the health and safety policies:

The Livingston Public Schools will comply with NJDOH Guidelines and make adjustments to plans on an ongoing basis. All current policies regarding the health and safety with children with disabilities can be found in District Policy 1648 and District Policy 1648.02. Students who receive special education and related services, as required by their Individualized Education Plans (IEP), will receive the services delineated in their IEP. Students who have Individualized Health Plans and Section 504 Plans will also receive all identified accommodations in those plans. For specific questions and further information, parents will continue to be encouraged to contact their child's case manager and/or the District Directors of Special Education.

Staff have engaged in professional development this year to ensure they are meeting the needs of our students daily. Intervention, programs, and consultations occur regularly.
