STRATEGIC PLAN STRAND 6 – FACILITIES

• Strategic Goals

- To provide and maintain schools that offer a safe and supportive climate for teaching and learning, are compliant with the American Disabilities Act and are environmentally sustainable
 - Maintain, replace and/or renew facilities, grounds and other capital resources in an equitable manner
- To establish a *Facility Utilization Plan* to ensure appropriate facilities are available for an inclusionary special education program, the alternative high school and pre-school P.R.I.D.E. (Preschool Readiness Individualized Developmental Education) program
 - Establish/reconfigure space to provide appropriate environments for emerging programs and technological needs

FACILITY CAPACITY USAGE

- Currently all classrooom space in each elementary building is being utilized
 - All elementary buildings are utilizing a computer lab, art room and music room
- MPMS, HMS and LHS have sufficient capacity for the long term future

SOFT BORDERS - HISTORY

- In January of 2005, a focus group was put together to study the issues of a growing elementary school enrollment and where to educate students
- The group examined options generated by the school administration to determine their viability
- Concern was not enough sections in some buildings to handle the number of incoming students
- Decision was made to establish guidelines on how to redistrict all incoming kindergarteners in the event that all available space had been utilized in a particular school

SOFT BORDERS – REASSIGNING INCOMING STUDENTS

- New Kindergarteners that have siblings in the elementary school and would be there simultaneously would not be reassigned
- Criteria to be utilized in determining reassignment:
 - Safety
 - Balance of class sizes
 - Transportation
 - Location
 - Space Availability
- New assignment for those students would be permanent
- Parents to be notified by June 1st as to Kindergarten placement

SOFT BORDERS – REASSIGNING INCOMING STUDENTS (CONT'D)

• Reassigns a small number of students that have not attended school and has the least impact on the majority of people

• Allows all schools to have a computer lab, art room and music room

DEMOGRAPHIC STUDY (PAST AND PRESENT)

- The demographic study completed in 2005 predicted elementary schools capacity issues would be resolved by 2009-2010
- The demographic study completed in 2010 showed the trend is for stable or slightly declining enrollment
 - In fact, 2010-2011 Kindergarten 10.3% higher and 2011-2012 Kindergarten 14% higher than projected

BALANCE POINTS

- Demographic studies project the trend but all projections have been too low
- All Elementary Schools just now reaching 100% capacity
 - Redistricting not viable
- 129 Special Education students are assigned out of district
- Current Kindergartener reassignment is emotional for some parents
- Is the economic climate conducive to long term solutions? (construction/increasing ES capacity)

ELIMINATING SOFT BORDERS

• Alternative 1

- Increase class size
- Class size disparity between schools

• Alternative 2

- All available classroom space could be utilized
- Affects computer labs, art and music rooms
- Limited classroom space for the return of Special Education students to base schools
- Increase to budget by hiring of staff

OTHER AREAS OF NEED

• LHS Referendum – Uncompleted Items

- Decision to provide air condition for all areas except old main gym (\$500,000)
- Several roofs were not part of the renovation (\$600,000)
- Elementary Schools/Middle Schools
 - Air condition gyms (\$2,000,000)
 - Enlarge and improve Media Centers at Collins, Harrison and Riker Hill
 - Additional elementary classroom space for instruction
- Alternative High School
 - New Location
 - Renovate Monmouth Court (\$2,000,000)

ALTERNATIVE HIGH SCHOOL

• Alternative High School – Location Options

- Monmouth Court
- LHS
- Other town or lease facilities (Recreation Building, Senior Community Center, Municipal Complex)

ALTERNATIVE HIGH SCHOOL MONMOUTH COURT

• Monmouth Court – Pro's

- Close but separate facility from LHS
- Built as a school
- Has a gym for Physical Education instruction
- Monmouth Court Con's
 - Not owned by Livingston Public Schools
 - Facility built in 1950s with no renovations
 - Electrical service deficient
 - No compliance with ADA
 - Heating unit is very old; no air conditioning
 - Many cosmetic issues from age, floors, paint, doors, etc.
