#### Refining Remote Learning Plan

- Reflecting on past experience (survey and focus groups).
- Connecting students to teachers and classmates.
- Daily / Weekly Schedule for Each Grade Level.
- Amount of asynchronous vs. synchronous instruction.
- Assessment and Grading practices at each grade level.
- Technology needs and practices.
- Professional Development for staff.
- Health and Wellness efforts if students remain home.
- Engaging and preparing parents and families.

### Preparing for Possible In-Person Instruction During a Health Emergency

- **Facilities:** Ensuring safe learning environment for all students and staff.
- Wellness: Health protocols and procedures to provide for a safe environment
- **Governance:** Clear policies and procedures in order to allow for a cohesive community understanding of operations.
- **Program/Instruction:** Ensuring strong teaching and learning programs both through instructions and extracurricular programs. Consideration special education needs.
- Technology: Enhancing our ability to provide remote or hybrid learning
- **Operations:** Getting our schools ready to support a socially distanced, healthy, and safe environment.

- Begin creating health related policies and procedures in anticipation of summer programming.

## Tentative Timeline for Reopening July

- Creation and engagement of Taskforce and subcommittees
- Draft of District Plans for reopening and remote learning.
- Continued engagement of administrative planning committees.
- Remote Learning Focus Groups



### Tentative Timeline for Reopening August

- Continued work of Taskforce and subcommittees
- Department of Education for approval for reopening plan and revised remote learning plan.

- Professional development opportunities provided for staff on health and safety and instruction.
- Communication of plan to stakeholders / families / staff.
- Facilities work completed if needed.
- Preparation of facilities and technology for school opening.
