A **Workshop/Voting Meeting** of the Livingston Board of Education was held on this date in the Administration Building and via Zoom and Facebook Live. On behalf of the Board, Mrs. Khanna acknowledged the tragic events that occurred in Israel last week and expressed that our hearts go out to those directly and indirectly affected. Mrs. Khanna added these events remind us of the importance of peace, tolerance, respect and understanding within our community and our world.

Superintendent's Report

Dr. Block announced that this week's Spotlight newsletter highlights our National Merit Scholarship Semifinalists and offered his congratulations to them. These students will be honored at our December board meeting.

Dr. Block congratulated Chloe Marrache for earning a perfect score on a college-level Advanced Placement Exam. Miss Marrache is one of only 357 students in the world to earn every point possible on the AP Research Exam.

1. NJSLA Report

Mrs. Natalie Topylko presented the NJSLA Spring 2023 results from the following assessments: NJSLA English Language Arts and Literacy Assessments in grades 3-9, NJSLA Mathematics Assessments in grades 3-8 and Algebra 1, Geometry and Algebra II and NJSLA Science Assessments in grades 5, 8 and 11. Mrs. Topylko reviewed the participation levels and went through the data showing students meeting/exceeding expectations in all of the assessments.

Mrs. Topylko concluded that moving forward the data teams are digging deeply into the beginning of the year assessments and triangulate these with the NJSLA scores, classroom observations and assessments; they will provide an emphasis on differentiation to ensure that small group instruction targets the needs identified by the assessments; they will continue to focus on analytical writing, continue with the implementation of Math in Focus in Grade 5 and will examine Grade 8 math inclusive of instructional materials, program and professional development for teachers.

Student Representative's Report

Mr. Ferrans thanked Dr. Block for the District Goals report and stated per Mr. Cohen's request, he has been gathering data about how students in the middle and high school feel about unstructured times and will bring that information to next week's meeting.

Mr. Ferrans announced that last week the SGA organized a poster where students highlighted what they appreciated about the custodians in celebration of National Custodian's Day.

Mr. Ferrans announced this week is Homecoming Spirit Week and students are celebrating by dressing in different themed clothing each day, holding a Homecoming Pep Rally on Friday, attending the Homecoming Football game on Friday night and participating in a Homecoming Dance on Saturday night.

Public Comment

Shilpa Kulkarni, Livingston, is the founder of Shiv's Third Eye, a non-profit organization dedicated to promoting inclusivity and acceptance. Mrs Kulkarni announced that due to the tragic events over this weekend, they have extended the deadline for accepting entries for its "MindSpeak" essay competition to Sunday, October 15. The essay competition is open to all New Jersey middle and high school students in an effort to give children a platform to illuminate the essential topic of youth mental health using their unique experiences and insight. An awards ceremony is scheduled for November 5 at the Youth Mental Health Wellness Fair being held at Livingston High School. Mrs. Kulkani encouraged everyone to attend.

David Lipsic, Livingston, suggested the district hire an independent security consultant to perform a security evaluation of our schools.

Harsh Raju, Livingston, asked if the raw data from the equity study will also be shared along with the process data and Dr. Block responded that yes, it will all be included in the study that is presented to the public.
